### **Change in Traffic Pattern Notice**

Columbus Avenue between W. 64<sup>th</sup> Street and W. 62<sup>nd</sup> Street

#### **EFFECTIVE TUESDAY FEBRUARY 2, 2016**

To facilitate the 42" Sewer work required in Columbus Avenue, from W. 64<sup>th</sup> Street to W. 62<sup>nd</sup> Street, the New York City Department of Design and Construction (NYCDDC) has reconfigured this work site. This operation is expected to be completed in three (3) to four (4) months.

There will be (1) lane on the west side of Columbus Avenue and one (1) lane on the east side of Columbus Avenue, construction in the middle of the road. All crosswalks in the intersections of Columbus Avenue from W.64<sup>th</sup> Street to W.63<sup>rd</sup> Street will be open. The crosswalk at W.62<sup>nd</sup> Street north side will be closed to pedestrian traffic. Please note:

-Traffic agents and uniformed flaggers will be on site to assist in the transition. Temporary closures may be necessary at times, as a safety precaution, and barrier(s) set-up is subject to change, as needed.

-Access-A-Ride Bus stop is temporarily relocated to W.62<sup>nd</sup> Street between Columbus Avenue and Amsterdam Avenue approximately 200' west of Columbus Avenue. -MTA Bus stop at W.62<sup>nd</sup> Street is temporarily relocated to W.60<sup>th</sup> Street.
